- I/We HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, snowmobile owners, driver, pit crews, any persons in the restricted area, promoters, sponsors, advertisers, owner, leases, of the premises used to conduct the event and each of them, their officers, agents and employees, all for the purposes herein referred to as "Releases:", from all liability to the undersigned, my/our personal representatives, assigns executors, heirs and next of kin for any and all claims, demands, losses, or damages on account of any injury, including but not limited to the death of the participant or damage to property, caused or alleged to be caused in whole or in part by the negligence of the "Releases" or otherwise.
